SECTION VII: HEALTH HAZARD DATA

CARCINOGENICITY: None of the ingredients are known / listed carcinogens, however, product may contain trace amounts of crystalline silica and wood dust, which are listed by IARC as a potential human carcinogens. Trifluralin has shown limited evidence of carcinogenicity in animal studies and is listed as a Class C (possible human) carcinogen.
